Foreword

Publishing information

This part of BS 6465 is published by BSI Standards Limited, under licence from The British Standards Institution, and came into effect on 31 March 2020. It was prepared by Technical Committee B/209, General building codes. A list of organizations represented on this committee can be obtained on request to its secretary.

Supersession

This part of BS 6465 supersedes BS 6465-3:2006, which is withdrawn.

Relationship with other publications

BS 6465, Sanitary installations, is issued in four parts:

- Part 1: Code of practice for the design of sanitary facilities and scales of provision of sanitary and associated appliances;
- Part 2: Code of practice for space requirements for sanitary appliances;
- Part 3: Code of practice for the selection, installation and maintenance of sanitary and associated appliances;
- Part 4: Code of practice for the provision of public toilets.

Part 1 provides recommendations for the design of sanitary facilities and scales of provision of sanitary and associated appliances in new buildings and buildings undergoing major refurbishment. It also covers the recommended scale of provision of portable toilets.

Part 2 provides recommendations for the space requirements around all sanitary appliances to ensure convenience in use and to facilitate maintenance and cleaning.

Part 4 provides design considerations and recommendations for assessing the positioning and number of public toilets. It also includes publicly available toilets.

Information about this document

This is a full revision of the standard, and introduces the following principal changes.

- The standard has been extended by over 20 pages from the 2006 edition.
- Although the basic section structure of general/selection/installation/maintenance remains, there has been substantial restructuring within those sections.
- The document has been updated to reflect practices and expectations of the early 21st century.
- Revisions to other parts of BS 6465, along with relevant standards such as BS 8300 and BS EN 752, have been taken into account in revising this part of BS 6465.
- Changes in legislation within the UK and Europe have influenced the guidance provided.
- New figures and text have been produced to explain the backflow prevention techniques needed for installations connected to UK water supplies.
- New tables have been added to aid the selection of various items, including drainage systems and WCs. Existing tables have been revised and often extended to cover new and emerging options as well as new legislation.

Section 1: Scope, normative references and definitions

1 Scope

This part of BS 6465 gives recommendations for the selection, installation and maintenance of sanitary (water-using and waterless) and associated appliances to be provided in new and refurbished buildings.

It does not cover specialist appliances, such as those used for commercial laundry or catering premises, or those found in hospitals, health spas, laboratories and similar establishments.

NOTE 1 Sanitary and associated appliances in hospitals and other healthcare buildings are covered by the general recommendations of this standard. Information on the scale of provision, ergonomic data and the special requirements for sanitary and associated appliances in hospitals can be found in the various guidance documents produced by NHS, e.g. Health Building Note 00-10 [17].

This part of BS 6465 does not deal with the detailed provisions of water supply, sanitary pipework or drainage.

NOTE 2 Information on water supply is given in BS EN 806 (all parts) and BS 8558; sanitary pipework in BS EN 12056-2; and drainage in BS EN 752.
